53 **Section 3.** Repeal. Ordinance 98-06 is hereby repealed in its entirety and shall no  
54 longer have any force or effect. In addition, all sections or parts of sections of the LaBelle Code  
55 or other ordinances of the City in conflict herewith are hereby repealed to the extent of such  
56 conflict.

57

58 **Section 3.** Codification. This ordinance shall be incorporated into the City of LaBelle  
59 Land Development Code. The sections of this Ordinance can be renumbered or re-lettered to the  
60 appropriate word or phrase to accomplish codification. Omissions, grammatical, and  
61 typographical errors, as well as clarifications of ambiguous wording that do not affect the intent  
62 of this Ordinance, may be authorized by the Mayor without need for a public hearing.

63

64 **Section 4.** Severability. In the event that any portion of this Ordinance is for any  
65 reason held invalid or unconstitutional by any court of competent jurisdiction, such portion shall  
66 be deemed a separate, distinct and independent provision, and such holding shall not affect the  
67 validity of the remaining portions of this Ordinance.

69 **Section 5.** Conflicts. The provisions of this article shall supersede any provisions of  
70 existing ordinances in conflict herewith to the extent of said conflict.


72 **Section 6.** Effective Date. This Ordinance shall take effect immediately upon its




